You could still see blood on Randee’s uniform from the fight and the bruises on his head.....

Despite the fact that this option has resulted in increased fire and safety threats, the indoor growing trend continues its upward spiral. During this quarter, the ***published seizures*** of both indoor and outdoor grows in California alone were 100,945 plants in varying stages of maturity and 407 pounds of finished marijuana.

Fire in San Jose home turns into major marijuana find

SAN JOSE, Calif.: A small attic fire in a San Jose home has turned into a major marijuana discovery. When firefighters responded to a report of smoke coming from an attic of the house Tuesday evening, they found marijuana plants growing throughout the three-bedroom residential home. Authorities say there were nearly 200 marijuana plants, with an estimated street value of up to \$1 million in the house. A fire official says the residents of the home had installed an elaborate ventilation system for the plants. The electrical circuit had also been bypassed, so the occupants weren't paying for electricity.

Marijuana Dispensaries Linked to Fatal Car Crash

Dispensary Sold Drugs to Man Who Crashed into C.H.P. Officer While Under the Influence of Marijuana

MAY 27 --(LOS ANGELES) The owner-operator of six Los Angeles-area “medical marijuana” dispensaries and his wife were arrested this morningAuthorities are seeking a third defendant, an employee who allegedly sold a pound of marijuana out the back door of one of the dispensaries. The investigation.....began after a horrific accident in which a CHP officer was critically injured and the driver he had stopped was killed. *“The consequences of marijuana use extend far beyond those who abuse and traffic the drug,” said Timothy J. Landrum, Special Agent in Charge of the DEA in Los Angeles. “The individuals arrested today claimed to sell marijuana for medicinal use, but it is clear that they are nothing more than drug traffickers.....*CHP Officer Anthony Pedefferri was conducting a routine traffic stop on the shoulder of Highway 101.....Parra was killed, and Pedefferri was gravely

injured. He remains paralyzed. The pick-up truck was driven by Jeremy White, who is currently being prosecuted by the Ventura County District Attorney's Office for gross vehicular manslaughter while intoxicated. The investigation revealed a large amount of marijuana and marijuana edibles in White's vehicle. White acknowledged being under the influence of marijuana when the accident took place, saying he had purchased the marijuana from a "medical marijuana" dispensary in Compton. "This case demonstrates the harm that can occur when individuals seek to line their pockets while operating under the guise of California's medical marijuana laws," said United States Attorney Thomas P. O'Brien. ***"The dispensaries involved in this case were simply drug-dealing enterprises designed to generate profits for those who chose to ignore federal law and flout state law. As stated earlier, the use of indoor grows is expanding. Enforcement agencies in other states and Canada are conducting investigations and beginning to take enforcement actions against the equipment suppliers and real estate agents involved in these grow operations.

New target in fight against indoor marijuana growing

TUKWILA, WASH. -- ***First they noticed a spike in home-based marijuana growing operations. Seattle-area authorities shuttered 450 indoor pot farms in two years.*** Then they zeroed in on the supply chain, targeting businesses that provide goods and services needed to grow the illegal weed indoors. Then they went after a mortgage loan company they say financed houses in which the plants were grown. After a 13-month investigation. the Task Force arrested more than a dozen people, seized 15,000 plants and uprooted a suspected pot-growing network. The indictments alleged that the stores had peddled equipment used to manufacture marijuana: soil, pots, fertilizers, pesticides, lights, fans and watering systems as well as specialized items such as electrical diversion equipment and air filters. They also allegedly provided "starter plants. Internal Revenue Services agents also scoured the records of Jet City Mortgage in Kent in connection to possible mortgage fraud related to homes where indoor marijuana crops were found." DEA investigators said one of the garden supply businesses ran newspaper ads showing marijuana leaves and pictures of growing equipment.

Grow ops sprout in upscale 'burbs

.....Experts say grow ops are being found in virtually every neighborhood in Calgary, with major operations leaving homes in a decaying mess of mould costing tens of thousands of dollars to repair.....We have no idea at this point whether we have 3,000 grow-op houses or 10,000. But, we do know it's a serious problem." "We're talking seasoned criminals," Plecas said. "And that also fits to the whole matter organized crime is into it up to its eyeballs." The profits from growing marijuana are so large that homes prove to be an expendable cost of doing business. "Most of the time they just don't care how beat-up the house becomes," said Vicki Wearmouth, a Calgary public health inspector specializing in grow ops....Often, she finds the exhaust from the furnace and hot water tanks are disconnected so CO2 filters out and spurs the growth of plants. A hole is burrowed through the foundation walls where growers steal electricity and bypass the meter.....If they've been going on for quite some time, there's a significant amount of water damage with the heat," Wearmouth said. That means a substantial and toxic mould problem. The properties must be "remediated" before they are again habitable. That can mean the entire home must be gutted to its bare bones; the drywall removed and the insulation stripped out. Such an extensive process can cost around \$150,000 depending on the size of home, says the executive vice-president of the Calgary Real Estate Board....The concern, Esch said, is when mould has infested the home, but the remediation process isn't adequate.....Esch estimates there are between 25 and 30 former grow-op homes on Calgary's multiple listing service at any one time....High power consumption is an emblem of marijuana grow ops. And a former Calgary police officer who left the service in 2007 has developed a special meter to detect those stealing electricity.....Morrison's meter detects atypical consumption between the primary line and the transformers that feed 80 to 100 homes in a neighborhood. The technology immediately notifies the utility company when a primary line shows a home with excessive consumption. Someone from the utility can then test the particular transformers and find out which residence is the culprit.There's no way the amount of marijuana that we're producing in Canada can be consumed by Canadians. "A vast majority of it is getting shipped down to the States where the profits are so much larger.".....Three years ago, the Surrey fire service began an experiment.....The department obtained power consumption data from BC Hydro on homes that were suspected of growing marijuana. Safety investigations based on high power consumption found nearly 94 per cent of the homes had serious electrical problems -- in almost all cases, they housed a grow op. In 2006, B.C. passed legislation requiring BC Hydro to provide the addresses of residences with unusually high power consumption. The first set of data in Surrey revealed almost 1,000 homes that met the threshold and were the likely abodes of marijuana grow ops....The solicitor general of Alberta also noted in a recent interview that many grow ops are simply stealing power and bypassing the meters. Fred Lindsay said by this fall the province will have two investigative teams that will act under civil law. If they inspect a home and find something awry, Lindsay said, "they will then have the ability to lock that house down for 90 days."

Detective Sgt. Chris Bertoli of Sonoma County handles the narcotics unit. ***"We are seeing a lot more grow operations involving medicinal marijuana, and we are finding that there are a lot of people taking advantage of the medical marijuana recommendations and using those to their advantage to increase their grow operations,"*** Bertoli said. What Bertoli and the grower do agree on, is the violence associated with home grow operations. ***"Every grower -- whether you live in the sticks or in downtown Oakland, Calif. -- wakes up every day with this ghost on their shoulder whispering,***

'Today could be the day your door gets kicked in; two or three guys come in with guns; you're duct-taped to a chair, and everything in your house gets taken,' the grower said. *"In the county of Sonoma and surrounding locations, we have seen an increase in the acts of violent crimes," Bertoli said.....The grower interviewed by NBC11 said that there might be unreported violence because of what the grower called police intimidation. "What happens? Do you call the police? No, you don't call the police," the grower said. "Why? Because you're afraid they're going to take all your lights and all the rest of the medicine;* and you're going to suffer further humiliation and further discrimination from the people who should be protecting you," the grower said.

Marijuana Linked to Heart Disease and Depression

Chronic marijuana use may affect the heart's health as well as the brain's. A [study](#) published yesterday in the journal Molecular Psychiatry found that chronic marijuana users—those who smoke on average nearly every day—may up their risk of both [heart attack](#) and [stroke](#). That finding comes on the heels of a government report that [linked pot use to psychiatric problems](#), including depression. Compared with non-users of the drug, heavy marijuana smokers in the new study had significantly higher levels of a specific protein in their blood known to increase triglycerides, which are fatty molecules linked to vascular and [coronary disease](#) risk.....Long-term and chronic marijuana abuse has been associated with adverse effects on the heart, too, says lead author Jean Lud Cadet, a molecular neuropsychiatrist at the National Institutes of Health, but scientists are only beginning to understand how the drug impacts the cardio- and cerebrovascular systems.....

Smoking Pot Could Have Lasting Effects on the Brain

A new study shows heavy marijuana use over several years was associated with structural differences in at least two different regions of the brain, the hippocampus and amygdala.The study also suggests that long-term marijuana users were more likely to report [symptoms](#) associated with mental disorders, although the strength of their symptoms didn't meet the criteria for diagnosis of mental illness.***The results showed men who smoked pot regularly had significantly lower brain tissue volumes in the hippocampus and amygdala areas, as well as more symptoms of mental disorders.*** Researchers say marijuana users also performed significantly worse on the verbal learning test, but these differences did not correlate with brain volumes in either group. "There is ongoing controversy concerning the long-term effects of cannabis on the brain," write the researchers. "Although modest use may not lead to significant neurotoxic effects, these results suggest that heavy daily use might indeed be toxic to human brain tissue."

US report says Marijuana strength increasing

Marijuana strength has increased to its highest levels in more than 30 years, according to a report by scientists.They found that the average amount of THC was 9.6 per cent in 2007, compared with 8.75 per cent the previous year and just under four per cent in 1983, the study by the University of Mississippi's Potency Monitoring Project found.The US Government believes the increase in potency is down to sophisticated growing techniques used by drug traffickers.Dr Mitch Earleywine, who teaches psychology at the State University of New York in Albany and is an adviser for marijuana advocacy groups, insisted that marijuana users had simply adjusted to the level of potency and smoked accordingly. He said: "Stronger cannabis leads to less inhaled smoke."

Their scores, many of which were low to begin with, showed the steepest decline after smoking the high-dose THC cigarette, followed by the low-dose THC cigarette.*** Researcher Barth Wilsey, MD, and colleagues aren't recommending medical marijuana for everyone with nerve pain. ***They urge "caution in the prescribing of medical marijuana for neuropathic pain," especially in light of the mental impact, and also in young patients, as pot use in adolescence "increases the risk of later schizophrenia -like psychoses, especially in genetically susceptible individuals."***

The advertising flier left no doubt about its pitch: a giant marijuana leaf with a phone number that ended GOT KUSH. A friend's teenage daughter brought it home from last weekend's Earth Day celebration on the Santa Monica Pier..... "Have you or anyone else experienced an illness [for] which you believe marijuana could provide relief?" the flier read. "If you don't qualify for a recommendation, your visit is free."I gave the polite, tattooed man behind the counter my driver's license, credit card and a coupon giving me a \$25 discount on the \$175 exam. Fifteen minutes later, I was greeted by the doctor,.....He looked over my medical forms and asked about the arthritis I'd noted. I told him the truth. Some days my fingers are so stiff it hurts to grip a doorknob or a steering wheel. I'd tried prescription drugs in the past, but stopped because of the side effects. The doctor inspected my swollen fingers, gently squeezing the tender joints. He checked my pulse and blood pressure, then took a stethoscope and listened to my lungs. His 10-minute exam was about as thorough as the one I'd received last year from the hand specialist at the orthopedic center, who sent me home with Celebrex. This new doctor told me marijuana could help.....

How I got my hands on some marijuana -- the legal (and easy) way.

May 9, 2008

Sometimes I can't believe how Californian California is.....I made an appointment at a medical office recommended by Shirley Halperin, the coauthor of the new book, "Pot Culture: The A-Z to Stoner Language & Life.".....As I sat in the tiny waiting room, filling out my medical history and getting nervous, Halperin assured me that no one she knows had been rejected, which seemed convincing because the only people sitting near me were two healthy looking guys in their 20s. When I got called in, I entered a doctor's office different from any I'd ever been in. It contained only a tiny desk, two chairs, a small TV and two cans of Glade. Also, the doctor wore a Hawaiian shirt. He took my blood pressure and asked what I was suffering from. "Anxiety," I said. And then "occasional insomnia." And even though he seemed to be moving on, I blurted something about headaches.....He'd give me a recommendation for medical marijuana for six months, he said, and would extend it to one year if I saw a therapist. ***The whole thing took about four minutes. I paid the receptionist \$80 -- cash only -- and she gave me a filled-out form that states I am under medical care and supervision for the treatment of a "medical problem."***.....The dispensary was like a really nice coffee shop, ...I settled on a gram of Sugar Kush,..... I got to spin a wheel to determine my free gift medicine, which was a pot-infused lollipop. I also bought a vegan chocolate-chip cookie medicine and a chocolate bar medicine, and deeply considered the gelato medicine. Wondering if I had an unusually easy time, I called High Times magazine's 2006 Stoner of the Year, Doug Benson....In fact, Benson buys all his pot from a dispensary now. Even with the sales tax, he pays the same price and, he said, gets more consistent quality than he did from a dealer.....***I always wondered what would happen if marijuana were legalized for anyone over 18. It seems it already has been, and nothing happened.***

High times for medicinal marijuana

In California, marijuana is supposed to be prescribed only to people suffering from life-threatening conditions but David Willis finds the reality is quite different.Soon, the doctor appeared - a softly-spoken Vietnamese man. *He wore a white lab coat and scrubs and led me into a spartan room where he proceeded to take my pulse and blood pressure before asking precisely how long I had been anxious. "Several years," I told him. "Do you suffer panic attacks?" "Not really." The doctor wrote panic attacks in his notebook. We spent a few minutes shooting the breeze about Asian cuisine and he signed a prescription for medicinal marijuana, valid for a year. And that was it. Done and dusted in less than 10 minutes*.....It was a short drive from the doctor's office and recently voted dispensary of the year by one of the pot smokers' magazines (the most famous of which is, incidentally, called High Times).....My prescription did not place a limit on the amount of marijuana I could buy a day and I asked the man with the trippy smile behind the counter what he recommended for anxiety. He pointed me in the direction of one called Purple Kush. "How much should I take?" The naivety of the question seemed to catch my moon-faced pot sommelier off guard. "I guess start with two or three puffs and see how you go...".....*Getting on for 250,000 Californians are said to carry prescriptions for medicinal marijuana, and who knows how many of them - like me - suffer from little more than the occasional bout of self-doubt.*

When I was smoking out of a bong I used fans, odor removers, sploofs, etc. Now that I'm smoking out of a vaporizer though, there's pretty much no odor and it's totally inconspicuous. If you really wanna step your game up, try a vape.

Answer 2

Yes, it is possible to get "legal" without medical records. Cheaper clinics are best. Yes, you can get it for ADD. Several guys on this board have. Big-time pot growers use Seattle-area homes

Narcotics investigators say large-scale indoor marijuana grow operations, such as this one found in the Kent area last year, cost about \$30,000 to set up but can yield \$1.5 million a year in profit. In place of a family, the home's primary "occupants" were 658 marijuana plants. In a good year, the harvest would be substantial enough to pay off the mortgage on the \$500,000 house and buy another home. Since 2005, federal and state agents have raided more than 100 large-scale grow houses in the Seattle area, yielding a bumper crop of more than 41,000 plants, according to the White House drug czar's office. Police last month found the biggest yet, a 1,500-plant grow that consumed most of a 3,800-square-foot house. *And Everett police were investigating a double homicide Monday in which two bodies were found in a home with more than 400 marijuana plants.* As the investigation gained traction, a police source described how Kent Distributor would provide on credit the \$20,000 to \$30,000 worth of equipment needed to set up a grow, to be repaid after the first harvest. the DEA did document that at least \$5.1 million flowed through the bank accounts of Kent Distributor and its owners since 2003, most of it cash. Canadian drug investigators have followed the money into the mortgage industry, where unscrupulous brokers falsified loans for pot growers. *Local law enforcement says a small number of real-estate agents and brokers were involved with many of the King County grow houses busted.*

.....In 1997, the liberal U.K. newspaper The Independent launched a campaign to decriminalize marijuana.....In March, 2007, ***The Lancet, Britain's leading medical journal, declared cannabis to be more dangerous and addictive than LSD and Ecstasy.*** About the same time, Professor Colin Blakemore, chief of the Medical Research Council (and in 1997, the moral authority behind The Independent's liberalization campaign) unequivocally reversed his cannabis-friendliness: "The link between cannabis and psychosis is quite clear now; it wasn't 10 years ago." As a result, The Independent last year offered its readership a fulsome apology: "If only we had known then what we can reveal today..." ***Psychiatry professor Robin Murray of London's Institute of Psychiatry estimates that cannabis usage is causally linked to a full 10% of the U. K.'s 250,000 bipolar patients:***we may see more people getting ill as a consequence."In order to better understand this sea change in experts' opinions and how it applies to Canada, I spoke with Ontario-based addiction counsellor and treatment/prevention specialist Don Smyth. As in Britain, Smyth explained, kids here are smoking a hybrid Middle-Eastern/Asian variety of cannabis that is far more intense and addictive than past varieties.***Smyth says, grimly concluding, "I am absolutely haunted by the irreparable harms this so-called innocuous drug has brought to the lives of [young users]."***.....
